RISK ASSESSMENT

Events / Bookings / Functions



OVERVIEW

This risk assessment template is designed to assist you 'the hirer' to carefully examine what could impact the delivery of or cause harm to people attending your event, booking or function held at VenuesWest facility. Workers and others have a right to be protected from harm caused by a failure to take reasonable control measures. You are legally required to assess the risks in your workplace, in this case your selected VenuesWest facility, so that you can put in place a plan to control the risks.

WHAT AREAS SHOULD BE RISK ASSESSED?

You are required to identify any significant risks associated with the working practices and products (event) that you will be bringing into the facility. Therefore, all of your activities, services and operations need to be assessed. In addition, you also need to judge whether the current control measures are suitable and sufficient to either eliminate, or adequately control, the risks identified.

Please note, VenuesWest will manage emergency response requirements for the safe evacuation of people from any effected areas or the venue. Those managing minors need to identify and plan for the safe transport and monitoring of those under their direct supervision, (i.e. school students and/or volunteers).

WHO SHOULD CONDUCT A RISK ASSESSMENT?

A competent person with a suitable and sufficient knowledge of the activities, services, operations and the premises would be ideal. An understanding of health and safety legislation and principles of risk assessment would be sufficient for a person to be considered suitable.

Risk should be discussed with co-workers, event workers and consult with other Person Conducting Business or Undertaking (PCBU) involved in the activities and confirm all hazards have been identified.

Once completed, this risk assessment should be distributed to contractors and other stakeholder for their input and comments.

RISK RATING (RR)	ACCEPTANCE CRITERIA
Low	Acceptable without further treatment when controls effectiveness is 'adequate' or better.
Moderate	Generally acceptable when controls effectiveness is 'adequate' or better and the risk can be demonstrated to be SO FAR AS IS RESONABLY PRACTICAL.
High	Significant Risk – Generally unacceptable. Routine and long-term risk exposures are not permitted. Implement risk treatment with urgency. CEO may approve exposure in emergency situations.
Extreme	Unacceptable Risk. Risk exposure not permitted without Board approval.
